

RESOLUTION NO. _____

A RESOLUTION AUTHORIZING THE MAYOR AND CITY CLERK TO ENTER INTO AN INFORMAL INTERLOCAL AGREEMENT BETWEEN THE CITY OF NORTH LITTLE ROCK AND NORTH LITTLE ROCK SCHOOL DISTRICT FOR STREET IMPROVEMENTS ON MAIN STREET AT THE NEW HIGH SCHOOL PROJECT AREA; AND FOR OTHER PURPOSES.

WHEREAS, Ark. Code Ann. §§ 25-20-101 et seq. (hereafter “the Interlocal Cooperation Act”) provides for interlocal cooperation agreements between various political subdivisions of the State of Arkansas; and

WHEREAS, Section 104(h) of the Interlocal Cooperation Act allows cities, counties, and other units of government to enter into informal agreements to share resources without burdensome procedural requirements; and

WHEREAS, the construction project of the North Little Rock School District (“NLRSD”) for the new high school is underway; and

WHEREAS, the City of North Little Rock (the “City”) has recognized the need for repairs and improvements to Main Street, and NLRSD has advised the City of North Little Rock “(the City”) of its willingness to share in the cost of resurfacing and making improvements to the area while the high school construction project is underway; and

WHEREAS, the total estimated project cost for the Main Street Improvements Project is \$1,049,265.00 with the City being responsible for \$601,850.00 and NLRSD contributing \$447,415.00; and

WHEREAS, sufficient funds are available in the Carry Over Fund to pay the City’s portion of the project cost, and it is in the best interests of the City and its residents that the Mayor enter into an informal interlocal cooperation agreement with NLRSD to commence the Main Street Improvements Project for resurfacing and improvements in the area of the new high school.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the Mayor and City Clerk are hereby authorized to enter into an informal interlocal cooperation agreement between the City of North Little Rock and North Little Rock School District whereby the City will pay a portion of the project costs, or \$601,850.00, for the Main Street Improvements Project at the new high school, said agreement being substantially similar in form and content as the agreement attached hereto as Exhibit “A”.

SECTION 2: That the City's share for the Main Street Improvements Project, or \$601,850.00, is hereby appropriated from the Carry Over Fund.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval.





